The new prices are affective from the 1st january 2013 only

- ACCEPTANCE OF MEMBERSHIP IS SUBJECT TO THE FULL & ACCURATE COMPLETION OF AN APPLICATION FORM, TOGETHER WITH THE APPROPRIATE PAYMENT.
- There is no longer a 5% discount rate when paying a yearly membership in full, also there no discounts given to social clubs.
- ALL MEMBERS AGREE TO BE BOUND BY THE CONDITIONS OF MEMBERSHIP OF COUNTY CAVAN SWIMMING & LEISURE COMPLEX.
- ACCEPTANCE OR TERMINATION OF MEMBERSHIP IS AT THE DISCRETION OF MANAGEMENT.
- TEMPORARY SUSPENSION OF MEMBERSHIP WILL NOT BE ALLOWED UNDER ANY CIRCUMSTANCES.
- MEMBERSHIP IS NOT TRANSFERABLE TO ANY SECOND PARTY.
- ALL PATRONS, WEATHER MEMBERS OR NON MEMBERS, WILL BE ADMITTED TO THE FACILITIES ON A FIRST COME FIRST SERVE BASIS. IN THE CASE OF MAXIMUM USAGE IT MAY BE NECESSARY TO RESTRICT ADMISSION.
- IN ORDER TO GAIN ADMISSION TO THE FACILITIES EACH MEMBER MUST PRODUCE A MEMBERSHIP CARD AT RECEPTION. THOSE WITHOUT A MEMBERSHIP CARD WILL BE CHARGED AT THE APPROPRIATE HOURLY RATE.
- IF ANY MEMBER WISHES TO TERMINATE HIS/HER MEMBERSHIP BEFORE IT WOULD NORMALLY EXPIRE, NO REFUND OF SUBSCRIPTION WILL BE MADE.
- COMPENSATION WILL NOT BE GIVEN IN THE EVENT OF ANY TEMPORARY CLOSURE OF ALL OR PART OF THE COMPLEX/FACILITIES.
- CHILDREN UNDER 8 YEARS ARE NOT PERMITTED TO BECOME SOLE MEMBERS. EACH SUCH APPLICATION MUST BE ACCOMPANIED BY AN ADULT APPLICATION.
- USE OF THE FACILITIES IS STRICTLY SUBJECT TO THE RULES AND REGULATIONS OF COUNTY CAVAN SWIMMING & LEISURE COMPLEX.
- A SCREENING FORM AND INDUCTION MUST BE FILLED IN BEFORE USING THE FITNESS SUITE.
- SMOKING IS NOT PERMITTED IN ANY PART OF THE BUILDING.
- NO DRINKING GLASSES OF GLASS BOTTLES ARE ALLOWED IN THE BUILDING.
